Service Bulletin No. 554

Supplement No. 3 to Lycoming Service Bulletin No. 554 provides the following additions and revisions to Service Bulletin No. 554, Supplement No. 1 and Supplement No. 2 to Service Bulletin No. 554.

- 1. Service Bulletin No. 554 affects:
 - A. All factory new, factory rebuilt, and factory overhauled engines listed in Table 1 of Service Bulletin No. 554.
 - B. O, IO, TIO, LTIO and AEIO-540 engines that have had a crankshaft bolt replaced during field maintenance or field overhaul between November 27, 1996 and the date of this supplement.
 - C. O, IO, TIO, LTIO and AEIO-540 engines that were repaired at Lycoming between November 27, 1996 and November 10, 1998, regardless of whether the serial number is listed in Table 1 of Service Bulletin No. 554.
- 2. Service Bulletin No. 554 does not affect:
 - A. Engines with single drive dual magnetos.
 - B. Engines that have had Gear Bolt Replacement Kit P/N 05K19987 installed in compliance with Service Bulletin No. 554.
 - C. O-540-F helicopter engines that have complied with Lycoming Special Advisory No. 48-798 and A.D. 99-03-05 and Robinson Service Bulletin No. SB-29, <u>unless</u> the crankshaft bolt has been replaced after the compliance.

The following engines that were listed in Table 1 of Service Bulletin No. 554 are in compliance with Lycoming Special Advisory No. 48-798 and A.D. 99-03-05 and Robinson Helicopter Service Bulletin No. SB-29 and are not affected by Service Bulletin No. 554 <u>unless</u> the crankshaft gear bolt was replaced after that compliance.

- 3. Plating of the bolt can result in a wide range of coloration; therefore, using the color of the bolt is not a reliable method of identifying acceptability.
- 4. RECALL OF BOLTS FROM REPAIR STATIONS. Lycoming requires that all STD-2209 crankshaft gear bolts from Maintenance Facility stock except those that are included as part of a gear bolt replacement kit, be returned to Lycoming.
