SERVICE LETTER

Service Letter No. L240A
(Supersedes Service Letter No. L240)
May 27, 2009

TO: All Owners and Operators of Lycoming Aircraft Engines
SUBJECT: Part Numbers Identified by Lycoming with -70 or -85 Suffix

The purpose of this Service Letter is to inform owners and operators of Lycoming aircraft engines what is indicated by the -70 or -85 suffix on the end of a Lycoming part number.

The -70 suffix, (Example: 13F47727-70, crankshaft) on the part number indicates:

Any part number assigned that covers overhaul of a component by Lycoming, or its supplier, that conforms to tolerances or parameters identified in the appropriate Lycoming or supplier overhaul manual.

The -85 suffix (Example: 13F47727-85, crankshaft) on the part number indicates:

Any part number assigned that covers a rebuilt service component by Lycoming, or its supplier, that conforms to new component configuration in accordance with 14 CFR 43.2.

NOTE

Part numbers with -70 or -85 as a suffix to the part number are parts other than the Mandatory Replacement Parts listed in the latest revision of Lycoming Service Bulletin No. 240.

WARRANTY POLICY:

A. -70 Parts

The equipment, as listed herein, is sold "as is/where is". Seller makes no warranties whatsoever. Seller specifically excludes all implied warranties, including, but not limited to, the implied warranties or conditions of merchantability and fitness for a particular purpose. It is further agreed that seller excludes any and all liabilities, and purchaser waives and releases any claims which may hereafter arise or accrue in his favor, based upon any obligation, liability, right, claim or remedy in contract or in tort (delict), including product liabilities based upon strict liability, negligence, or implied warranty in law and purchaser hereby waives such rights and claims. Seller excludes liability, whether as a result of a breach of contract or warranty, negligence or strict product liability, for incidental or consequential damages, including, but not limited to, damage to the equipment or other property, local customs fees and taxes, and costs or expenses for commercial losses or lost profits due to loss of use or otherwise.

B. -85 Parts

Recipients are hereby notified Lycoming Engines standard part warranty applies.
